



Qualification of Applicants

- □ Non-Chinese citizen.
- □ Not currently registered in SJTU at the same degree level.
- Good health both physically and mentally.
- Outstanding academic performance and potential.
- Bachelor's degree or equivalent. The degree must be ready prior to the registration day.
- Documents of English (IELTS 5.5/TOEFL 90pts or above)
- GRE or GMAT is optional.

Note:

Being born in a native English-speaking country is not a proof of your English proficiency. You will be deemed to have satisfied the English language requirements if you can provide evidence that you meet one or more of the following criteria: i) English Language Tests ii) Prior study in the medium of English

Application Procedures

Step 1: Complete the Online Application http://isc.sjtu.edu.cn/EN

Step 2: Pay the Application Fee

The application fee is 800 RMB (or 120 USD), non-refundable and non-transferable. You can choose online payment or bank transfer in the online application system.

Required documents for uploading:

- □ A bachelor's degree from a university or college;
 - Students in their final year of undergraduate study may be admitted on the condition that their bachelor's degrees are awarded before they enroll at SJTU. An On-campus Certificate will be fine.
- Official undergraduate transcripts;
- □ Valid TOEFL report, or academic IELTS report;
- Two letters of recommendation from associate professors or above;
- □ A copy of passport;

Documents in Item 1 and Item 2 should be original documents or notarized copies in English.

Tuition Fee

Tuition for the entire program is RMB 188,000, and should be paid in two annual installments.

Scholarships

SJTU offers different kinds of scholarship for excellent applicants, such as Chinese Government Scholarship, Shanghai Government Scholarship, SJTU Scholarship, and others. The application process is centrally managed and controlled by SJTU Graduate School, and the timelines and procedures follow the University schedule.


